# DUTY STATEMENT AND SELECTION CRITERIA: SCA POLICY DIRECTOR

#### The Company

The Sheepmeat Council of Australia (SCA) was formed in 1979 and is the peak national body that represents and promotes the interests of lamb and sheepmeat producers in Australia. Our core business is policy development and lobbying.

Sheepmeat Council's key role is scrutinising the performance of and setting the strategic imperatives to be pursued by levy funded bodies, in particular, Meat & Livestock Australia (MLA), Animal Health Australia (AHA) and the National Residue Survey (NRS), and ensuring these are consistent with the Sheepmeat Industry Strategic Plan.

The organisation is based in Canberra and employs four full time staff.

This position is a Canberra-based position that would suit an experienced manager.

# **Role Purpose**

This is a senior role within the organisation which will incorporate some management responsibilities. It may require the ability to act for the Chief Executive Officer when they are unavailable, as well as the ability to cover ad hoc sheep industry policy issues.

In addition you will be expected to carry principle policy responsibility for the following areas:

- Animal health, animal welfare, biosecurity and traceability; and
- Research, development and adoption.

You will also be expected to respond to media inquiries.

The Policy Director reports to the Chief Executive Officer.

# **Position Responsibilities**

- General oversight of policy.
- Assume leadership and accountability for the management of SCA's involvement in projects and committees relevant to your portfolio responsibilities.
- Assist the CEO with management responsibilities.
- Research and prepare draft responses, submissions, briefing papers and correspondence for SCA.
- Act as Secretariat for SCA's Animal Health and Welfare and Research and Development Subcommittees.
- Lead, coordinate and present on relevant policy issues and projects to SCA Council meetings, to facilitate the development of sound SCA policy.
- Assist in strategic planning and implementation strategies for SCA and the broader sheep industry.
- A leadership role in building, maintaining and growing strong professional working relationships with stakeholders including producers, government and members.
- Manage and coordinate SCA's Emergency Animal Disease (EAD) preparedness.
- Prepare reports and other documentation for submission to AHA, the Australian Government, MLA, NRS and other relevant organisations to meet SCA's obligations under contracts and MoU's.

# **Selection Criteria**

The successful candidate will:

- Have strong policy development skills with a demonstrated ability to research, analyse and prepare accurate advice on complex issues.
- Have some management experience.
- Have critical interpersonal and communications skills to manage stakeholder relations and represent and negotiate on behalf of the Council at meetings.
- Have project management skills with the ability to deliver results against tight deadlines and prioritise work in a changing environment.
- Be able to work independently and be adaptable to operate within a small staff environment..

Experience in communicating through the media, both electronic and print would be an advantage.
