- To arrange stock preparation, including scheduling, drafting, and reconciliation of stock weights.
- To manage all livestock related staff inclusive of manning and ensuring all employees, contractors and/or stock delivery drivers adhere to regulatory and company requirements
- Assisting the Feedlot Operations Manager with preparing cattle for Live export programs including all protocol and quarantine requirements,
- Assisting the Feedlot Operations Manager with supervising Central Agri Group's and other customer breeding and AI programs,
