

## Station Manager - Murrayfield Sheep Station

The Indigenous Land and Sea Corporation (ILSC) is a corporate Commonwealth entity established under the ATSI Act and subject to the PGPA Act. The ILSC assists Aboriginal and Torres Strait Islander people to realise economic, social, cultural and environmental benefits that the ownership and management of land, water and water related rights can bring. The ILSC provides this assistance through the acquisition and management of rights and interests in land, salt water and fresh water country.

ILSC Agribusiness is a specialised unit of the ILSC that focuses on the development and management of commercial agribusiness investments on Indigenous land in partnership with Indigenous people. ILSC Agribusiness currently operates agricultural businesses, including beef cattle, fine-wool merino sheep, a community-based meatworks and a cattle export depot.

Murrayfield operates a fine wool enterprise in conjunction with delivering significant, cultural, environmental and social benefits to Aboriginal people. Murrayfield regularly provides training and employment opportunities for Indigenous people. This includes providing opportunities for school-based apprentices to gain practical experience on an operating property.

Reporting to the Business Planning and Support Manager, the Murrayfield Property Manager will:

- Manage and help physically perform all tasks as required in the day to day operations on the station.
- Oversee management of all flock breeding programmes and animal husbandry requirements of the sheep flock on the Station in accordance with industry best practice and within the annual budget.
- Maintain the accreditation of Responsible Wool Standards, which covers the highest level of sheep welfare and environmental protection.
- Maintain a high level of biosecurity for the property, including managing unannounced visitors
  or trespassers, as well as ensuring that the currency of the property biosecurity plan is
  maintained.
- Management of all pasture maintenance, pasture improvement and cropping activities on the Station in accordance with the industry best practice and within the annual budget.
- Manage all Station records including flock, paddock, chemical register, plant and equipment, inventory, infrastructure maintenance schedules and financial records.

The preferred applicant will be engaged on a 3 year Fixed Term Employment offer with Australian Indigenous Agribusiness Company Pty Ltd, a wholly owned subsidiary of ILSC.
