

## Pastoral Project Officer

Territory Natural Resource Management is a not-for-profit organisation. We are the custodian of the NT Natural Resource Management (NRM) Plan, and work to advance strategic and sustainable natural resource management to protect the NT's environmental, production and cultural assets for the future. We develop and deliver NRM projects and activities across the Northern Territory in partnership with landholders, community groups, organisations and government.

Our Project Officers work in a busy and dynamic environment in a role that includes community engagement, project planning and delivery, and getting out in the field to work with and support our partners.

We are looking for a self-motivated person with a good knowledge and understanding of the pastoral industry and agriculture, and a passion for working with people to address NRM issues and opportunities.

### Key Responsibilities

- Supporting the successful and efficient planning, delivery and reporting of NRM projects to ensure that TNRM business and contractual obligations are met.
- Engaging producers in initiatives and activities that raise awareness of and support adoption of improved efficiencies, sustainability and management of natural resources. Project and field work coordination, including engaging and liaising with project partners and subcontractors, and managing logistics associated with project activities.
- Undertaking fieldwork including establishment of project sites and survey and monitoring activities. Development and delivery of community engagement and awareness raising activities and materials.

### Selection Criteria

#### Essential

1. Tertiary qualification and experience in agriculture, environmental or natural resource management or a related equivalent field.
2. Understanding of the Northern Territory pastoral industry and leading practices in pastoral land management
3. Knowledge of rangelands vegetation and an ability to undertake monitoring and assessment of land and vegetation condition.
4. Ability to effectively communicate and raise awareness about land management practices, and to support landholders in adoption of practices to improve efficiency, sustainability and management of natural resources.
5. Experience of engaging and working effectively with pastoral land managers, and facilitating people from diverse backgrounds to work together.
6. Ability to support the development, delivery, evaluation and reporting of projects to meet funding and contractual requirements.
7. Demonstrated capacity to coordinate, organise and undertake remote field work safely and effectively.
8. Willingness to travel to remote areas of the NT and work away from home for up to a week at a time, experience in remote travel and use of 4-wheel drive vehicles.
9. Australian residency and current Drivers Licence

1. GIS experience with capacity to collect, maintain and analyse GIS data
